1. Approach-ApproachConflict

- 2. Approach-Avoidance Conflict This conflict arises if in the same time arising out two motives the opposite of one object, the motive of which a positive (pleasant), the other negative (harmful, unpleasant). Therefore, there are doubts, whether

(c) Super Ego, Personality structure is the superego. According to the views of Freud, the super ego is the part of the moral or ethical personality. The Superego begins to develop at the time of the ego internalise social norms and moral. (d)The Defense Mechanism Of Ego, Freud defines the defense mechanism of the ego as a strategy used by individuals to prevent the emergence of open of impulses id and for the face of the pressure of the superego over the ego, with the aim that anxiety can be reduced or relieved(Koeswara, 1991:46).

All of it dashed and stopped in the middle of the road when rangga gives the wind of heaven: go on an adventure to Europe while finished Ph.D.(Hanum &Rangga 2015:16)

The conflict further which conflict is approaching-stay away. The conflict occurs when the Author is confronted by choices that have positive and negative sides. Starting from Hanum desire to be the reporter reliable as Cooper has always been his idol. Proceed with anxiety Hanum to be dutiful to her husband. Kebimbingan Hanum in taking decisions lead to inner conflict within himself.

Rangga handed subway tickets to hanum. Hanum was looking rangga glared at the ticket just now.What was on the ticket was unusual.
